

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to John&Angie.org and John and Angie International and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to John and Angie International include John&Angie.org, JAI, Reasology and www.Reasology.solutions. The JAI website is a Education site. By using the JAI website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, JAI may collect personally identifiable information, such as your:
